PUBLIC NOTICE OF CLAIM OF RIGHT

Issued by the Man of the Land, **Brad Weston**, on the 11th Day of December of the year 2021, in the CORPORATE Township of LUMBY, in the Province of BRITISH COLUMBIA.

i, a Man, born of the Land and Living upon the Land, give Public Notice of my Claim of Right and of Lawful Reason to convene and establish a Common Law Court by Divine Right as a Hu(Spirit)Man(Physical) born as a Man of the Land; and i do hereby call upon the Support of all competent WoMen and Men of the Land to assist me in this Lawful Right.

i further give Public Notice of my Claim of Right and of Lawful Reason to convene and establish as part of such a Court a Jury of my Peers, consisting of 12 WoMen and Men, to Hear a matter affecting the Health, Well-Being, Safety and Rights of a fellow WoMan of the Land, that matter being the following:

**The WoMen and Men ACTING as “Employees” for the service CORPORATION : VERNON JUBILEE HOSPITAL,
Kevin Stevenson, Pieter Aartsma, Arlene M. Doll, Gillin Hodge, Gus Richardson, Joan Croft,**

AND:

**The Man ACTING as a “Employee” for the service CORPORATION : THE ROYAL CANADIAN MOUNTED POLICE
R.C.M.P. Member : Forsyth**

v.

Myah St. Pierre

STATEMENT OF CLAIMS:

On November 15th, 2021 after receiving a complaint from Myah's Mother, a Member of the Royal Canadian Mounted Police, Forsyth located Myah, tackled her to the ground with UnLawful FORCE and caused significant bruising, swelling and cuts to her right knee.

Myah was taken to the Vernon Jubilee Hospital where she was admitted as a "Psychiatric Patient". A WoMan by the Name of Arlene M. Doll filled out and signed Form 6 of the "*Mental Health Act*" Claiming that a review panel reviewed the Case of Myah St. Pierre on November the 15th, 2021.

Arlene M. Doll signed the Document on December the 2nd, 2021, a full 17 Days after her Hospital Admission. Myah was admitted to Hospital Involuntarily.

According to the Mental Health Act Involuntary admissions :

22 (1) The director of a designated facility may admit a person to the designated facility and detain the person for up to 48 hours for examination and treatment on receiving one medical certificate respecting the person completed by a physician in accordance with subsections (3) and (4).

The Mental Health Act goes on to say:

(2) On receipt by the director of a second medical certificate completed by another physician in accordance with subsections (3) and (5) respecting the patient admitted under subsection (1), the detention and treatment of that patient may be continued beyond the 48 hour period referred to in subsection (1).

(3) Each medical certificate under this section must be completed by a physician who has examined the person to be admitted, or the patient admitted, under subsection (1) and must set out

(a) a statement by the physician that the physician

(i) has examined the person or patient on the date or dates set out, and

(ii) is of the opinion that the person or patient is a person with a mental disorder,

(b) the reasons in summary form for the opinion, and

(c) a statement, separate from that under paragraph (a), by the physician that the physician is of the opinion that the person to be admitted, or the patient admitted, under subsection (1)

(i) requires treatment in or through a designated facility,

(ii) requires care, supervision and control in or through a designated facility to prevent the person's or patient's substantial mental or physical deterioration or for the protection of the person or patient or the protection of others, and

(iii) cannot suitably be admitted as a voluntary patient.

The Admission Form used to UnLawfully Admit and Detain Myah St. Pierre, dated December the 2nd only states : "*our reasons to follow.*" The Document does not provide any valid reason or justification to hold Myah. It is noted that Arlene M. Doll was the only WoMan to sign Form 6 but claims to have signed on BEHALF of two others, a WoMan, Dr. Gillian Hodge and a Man, Gus Richardson.

Section (4) of the Mental Health Act also states that:

A medical certificate referred to in subsection (1) is not valid unless both it and the examination it describes are completed not more than 14 days before the date of admission.

The medical certificate dated December 2nd, 2021 is invalid and illegal as Arlene M. Doll has failed to fulfil all the required criteria under the Mental Health Act. It is dated 3 Days beyond the required date of validation and provides no Lawful or Legal reason to hold Myah St. Pierre. Arlene is holding Myah St. Pierre against her Will and Lawful Agreement. In addition, the Document was not witnessed and signed by members of the review panel.

On December the 2nd, 2021 Myah drafted and signed a letter that she handed to Kevin Stevenson, a Man ACTING as a Psychologist at the VERNON JUBILEE HOSPITAL. Myah wrote:

"I have not been provided with response from review panel December 2, 2021. Everything you do to me is under threat, duress and coercion! i am being held against my will.

Witnesses : Dawn May Somers, Heather Ann H., David E. Friesen and Nicolas Patatleo."

The WoMen and Men who are detaining Myah have been giving her injections and Pharmaceutical Drugs such as, but not limited to, Olanzapine, a typical antipsychotic used for the treatment of acute mania, schizophrenia, and other psychotic disorders in adults.

Myah has advised the WoMen and Men who are detaining her that she is not a Person, Patient, Resident or Property and that she does not Agree or Consent to being given Pharmaceutical Drugs or Therapies of any kind. Myah has informed her captives that she is a WoMan of the Land and wants to be released effective immediately.

She has asked her Captives if they consider her to be their Property, if they have a contract with her that relinquishes her unalienable Rights or a Contract with the Service CORPORATION that they work for that claims Myah as Property and relinquishes her unalienable Rights. The reply to all three questions was, "No."

In response to the UnLawful Harm that is being caused to Myah St. Pierre, i, a Man, Roy Vieira am hereby requesting the assistance of the Sovereign - Common Law Court of the Land to Hear my Claim and ask that a RELEASE NOTICE be issued to the WoMen and Men who are detaining Myah.

Myah St. Pierre is 22 years of Age, is of sound Mind, and has a clear conscience. She has a Safe Home available where she will be cared for by i, Roy Vieira and my Partner, the WoMan, Tori Olason. With her Agreement and acceptance, i vow to be the Lawful Guardian of Myah St. Pierre.

On this Day, Saturday December the 11th of the year 2021 i am calling upon 11 fellow Peers from my Community to hear my Claim on Short Notice set for the date of Sunday December the 12th at 4:00 p.m. - 5:00 p.m.

i further give Public Notice that the said Jury of my Peers Claims the Jurisdictional competence to Hear and Judge this matter and issue a decision and verdict within the said Common Law Court established to render such a Judgement, based upon proven and irrefutable evidence presented within its Court.

i hereby Publicly call upon and REQUEST the Support of my fellow WoMen and Men of the Land from within my **OWN** Community to establish this Common Law Court and for its Jury of 12 WoMen and Men, to be AFFIRMED as WoMEN and Men born of the Land and Appointed by way of OATH, to ACT with Honesty and integrity for the duration of the Court proceedings and to do so under the AUTHORITY of Divine Spirit within the Jurisdiction of Common Law of the Land in accordance with the rules of evidence and due process.

i make this Public Claim of Right on BEHALF of the WoMan, responding to the Name, **Myah St. Pierre**, without coercion or ulterior motive, in the Best interests of Lawful, and Legal Justice regarding the total Health, Well-Being, SAFETY and Rights of Members from the General Public, including, that of my fellow WoMen and Men born of the Land.
